I hereby waive any rights which I may have to sue the race organizers (the organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) with respect to personal injury or property damage suffered by myself or my crew as a result of our participation in this event and hereby release the race organizers from any liability for such injury or damage to the fullest extent permitted by law.

I have taken all necessary steps to ensure that I, my crew, and the entered boat are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that which a prudent seaman would consider advisable.
